Why do we have laws in Australia?


- To uphold "good order" of society, e.g. some driving laws - known as Criminal Law
- To protect relationships between different groups of people, e.g. doctor-patient - known as Civil Law
- There are also policies and other documents we may have to follow in specific settings e.g.
 Workplace Health and Safety at work



Three guiding principles

- 1. There are laws that protect all people from being harassed, taken advantage of or bullied online, in person, in specific settings or by specific people.
- 2. There are laws that people have a responsibility to follow in order to support society, e.g. driving laws, public order offences, e.g. property damage or graffiti, age-related restrictions on certain activities, e.g. tattoos and piercings, sex or drinking etc.
- 3. If you are facing a problem, it is still a good idea to talk to a legal service because they may be able to provide assistance.


